

## Training Course on

### **“Requirements and safety evaluation for RW management”**

*March 16-20, 2020 Rome (Italy)*

#### Objective of the training

To provide a complete overview of the RW management activities, related regulatory requirements and licensing procedures with focus on the role of the regulatory body.

#### Target audience

The training is dedicated to staff of: nuclear regulatory authorities, TSO organizations, Radioactive Waste Management Organizations and other companies dealing with RW management.

#### Participant background

It is useful to have basic knowledge of safety aspects characterizing the management of RW.

#### Program

The training program will present and discuss:

- The relevant regulatory requirements and safety review for activities related to RW classification, treatment, conditioning, storage and disposal.
- Particular attention will be given to RW storage facilities and disposal facilities for low, intermediate and high level waste.
- Licensing process, content of safety analysis and safety justification to be submitted for regulatory licensing review.
- The content of SAR for RW management facilities with related licensing review and approval, including objective and scope of onsite regulatory inspections.
- Reference standards and guidelines for regulatory review.
- Practical elaboration and evaluation are included.

#### Learning outcomes

Understanding and familiarization with:

- the knowledge, and learning of key aspects, of the safety objectives, safety requirements, content of safety analyses and regulatory activity to be performed for RW management and related regulatory licensing process.
